- 5. North 1/16th corner of Section 31. Not set in original survey, no evidence of subsequent establishment.
- 7. North 1/16th corner common to Sections 31 and 32. Not set in original survey, no evidence of subsequent establishment.
- 12. South 1/16th corner of Section 31. Not set in original survey, no evidence of subsequent establishment.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

- 3. Corner established mid-point and on line between the northwest and west quarter corners of Section 31.
- 5. Corner established mid-point and on line between the north quarter and center quarter corners of Section 31. Corner falls 3' SW of small brook.
- 7. Corner established mid-point and on line between the northeast and east quarter corners of Section 31.
- 12. Corner established mid-point and on line between the south quarter and center quarter corners of Section 31.
