CARLSON , in a field survey on <u>OCTOBER</u> 15TH _, 19_96 do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, recovered, found as expressed below:



Description of original monument and accessories and/or subsequent restoration: K-12: Quarter Corner common to Sections 35 and 36.

1845: Sam U. Hill's original subdivision survey notes describe the corner monument as a wood post referenced by: 13" Fir S80F 20 L 8"

1942: MCRC field book index indicates that the Quarter Corner common to Sections 35 and 36 is a 1" iron pipe with the following references: 3" Jack Pine N75W, 40.0' 5" Jack Pine S52E, 33.6"

1965: The corner is shown on a survey map by Wayne Classen L.S. #14088, and recorded in L. 72, MR Pg. 588. No accessories given.

Description of corner evidence found and/or method applied in restoring or reestablishing corner: K-12: 1996: Searched and found no original evidence. Found and accepted a 2 1/2" O.D. Iron Pipe with a 3" diameter brass cap welded on top, 1.2' high, and in good condition. Found an 18" diameter tree which appears to be a Jack Pine, S47E, 33.76' to C/L of stump at top. Distance and bearing to this tree matches very well with a 5" Jack Pine, S52E, 33.6' as recorded by the MCRC in F.B. 698 (No date given). This is the only found witness to this corner location, which was recorded at that time to be a 1" Iron Pipe. Line calls to North and South were not checked at this time as they are in excess of 2000'. Distance North is 2607.07 and Distance South is 2609.481.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: K-12: 1996: The above found monument was stamped to identify the corner, and was stamped "MCR 1996" to indicate it as a Marquette County Remonumentation corner. Painted pipe orange. Established references:

8" W. Pine S78E, 24.30' (d.h. nail N. side, 1.8' high) 8" W. Pine S78W, 55.91' (d.h. nail N. side, 2.3' high) 8" W. Pine 38.02' (d.h. nail W. side, 2.0' high) 104.10' (d.h. nail E. side, 1.8' high) \$27W, 6" J. Pine NO8W, 3.05'
