B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

A thorough search found no evidence of any survey monumentation or occupation in the immediate area. A thorough search round no evidence or any survey monumentation or occupation in the immediate area. No evidence of original B.T.'s could be found and line calls of the original GLO notes are not distinct enough to locate this point. No recorded survey information exists in the Marquette County Register of Deeds and no unrecorded survey information could be obtained regarding this corner. Considering the above information, we have physically established the one-quarter corner common to Sections 11 and 14 by single proportionate measurement. Orientation and measurement between this calculated location and adjacent section corners fit reasonably well.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

set standard Marquette County Remonumentation Monument, being a 2 3/8" diameter x 30" aluminum post with 3 1/4" diameter aluminum cap stamped with appropriate corner identification and "1998 PLATZ, 38121". Made the following new witnesses:
