B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(A2) Original post and accessories not recovered. Found no acceptable, evidence of the position of the original corner on the ground. Reestablished the corner on a straight line between Section corner 2619.47' south and closing corner 2285.48' north, being 40.00 chains, proportionate to the original record, north of the section corner. At the position for the corner, I placed a 1"IDx36" iron pipe capped with a 4" dia. cast aluminum MDNR tablet, appropriately stamped.
