

William Lenca Nov in a field survey on do hereby state that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and /or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented. recovered, found as expressed below:

A. Description of original monument and accessories and/or subsequent restoration:

1848: Original Survey by James H. Mullett - B.T.'s - Tamarack, 12" - N48°E - 32 lks.; Tamarack, 12" - S30°E - 16 lks.; All original evidence for this corner has been destroyed by years of decay.

1988: L.C.R.C. No. 803, Book 3, by William Lenca, RLS No. 26461states "found old squared post in location indicated by retracement of the South line of Section 20". Set 3/4" x 60" Alum. Pipe/3" Alum. cap stamped for corner location. TIES: Nail in 12" Tamarack, Scr. B.T., N55°E, 25.76'; Nail in 12" White Pine, Scr. B.T., N32°W, 24.85'; Nail in 6" Blue Spruce, Scr. B.T., S180E, 31.45'; Carsonite, SW, 2.17'.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

We found an HDR monument and three B.T.'s in place per L.C.R.C. No. 803 (see above). This corner fits well with measurements to corners 1/2 mile East and 1/2 mile West and has been accepted and used as survey control for several years, and is accepted as the best available evidence of the position of the original corner.
