- A. Description of original monument and accessories and/or subsequent restoration:
- I-3 Section Corner common to Sections 2, 3, 10 and 11. 1852: Francis Coleman, D.S., set wood post witnessed by: Black Ash 12 N55E 32 Lks.; Elm 10 S71W 46 Lks.
- K-1 Section Corner common to Sections 1, 2, 35 and 36. 1957: Billy D. Buckler, RLS, set 1" iron pipe with brass cap witnessed by: 5" Cedar S20E 42 Lks; 7" Tamarack S55W 17 Lks; 7" Tamarack N79E 14.5 Lks.
- K-3 Section Corner common to Sections 1,2, 11 and 12. 1955: Michigan DNR. Set 1" iron pipe witnessed by: 12" Red Pine S65W 59 Lks.; 18" White Pine S69E 56 Lks.
- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- I-3 No evidence of original survey or restoration found. Corner position re-established by double proportion between original corners one mile north and one mile east, a very well defined swamp edge to the south, and a position to the west calculated from recovered plat monuments of "Menominee Forest Estates No. 1".
- K-l Found monument and NBT's as described. Cedar is a blow-down with faces facing the ground. Measurements to tamaracks match well, but appear to have been recorded to wrong trees. Rewitnessed monument as found.
- K-3 Found monument and NBT's as described. Monument was bent over and cap was broken off. White Pine NBT is dead but still standing. Set new monument and rewitnessed.
