

A. Description of original monument and accessories and/or subsequent restoration:

48: Original Survey by James H. Mullett - B.T.'s - Tamarack, 4" - \$70°E - 33 lks.; Tamarack, 6" - N45°E - 39 lks.; All

original evidence for this corner has been destroyed by years of decay.

Survey by Albert Hass shows this corner and describes it as " Set 4" Cedar Post from Government B.T."

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

We were unable to find any evidence for the original corner or for Albert Hass' Corner. We set the Corner in line with an old established fence line running East and midway between the Section Corners 1/2 mile East and West. This position fits well with a GLO stream call 11.6 feet West and falls at the end of the old fence, and is accepted as the best available evidence of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Set 2" dia. Aluminum Pipe 30" long/3-1/4" dia. Alum cap stamped for corner location:
