

A. Description of original monument and accessories and/or subsequent restoration:

1852: Original Survey by Francis Coleman - B.T.'s - Cedar, 12"- N51°W - 07 lks; Cedar - 12", S45°E - 06 lks - All original evidence for this corner has been destroyed by county road improvements.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

In a 1994 survey of Section 9, we set this corner in the centerline of a North - South County Road, and at a distance halfway between the Northeast Corner and the Southeast Corner of said section. This corner position is accepted as a careful and faithful reestablishment of the position of the original corner.
