A. Description of original monument and accessories and/or subsequent restoration:	
J-11. One-quarter Corner common to Sections 26 & 35, T21N, R7W, was set as a post in 1856 by Deputy Surveyor, Colman, the corner was set on the West side of stream bed, witnessed by: N35°E - 17" Fir - 43 Links; N27 ½°W - 14" Elm - 63 Links County Surveyor visited this corner in 1894 and set a new stake with no witnesses given. James Granger Certificate of Survey in 1993 in Section 35 shows establishing the N-S ¼ line from a found center post with no reference made to the North ¼ corner. Mark Robison Certificate of Survey in 1995 of the SE ¼ of the NE ¼ of Section 26. Gives no witnesses on certificate. Per Phone call to Mark, He found a Bar & Cap witnessed by: North-29.70-Cable Sign; South-6'-CL Road; South-27.0-Gd rail post; \$45°E-34.0-Gd rail post. Craig Pullen Certificate of Survey in 1999 shows finding Bar & Cap #15410 (Del Porter) witnessed by: 7' North of CL Meyering Rd, \$49°E - Top of Guard Rail Post - 43.92', \$62°E - PK top of Guard Rail Post - 60.38', \$11°E- PK in Top of Gaurd Rail Post - 27.22', N11°E - Steel Post-29.66.	
B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:	
J-11. Found Bar & Cap #15410 from Pullen Survey. Position is 7' North of Centerline Meyering Rd. Position fits approximate Government call of the Stream Bank, and S.P. position between the Section Corners. No other evidence found from old GLO or County Surveyor or any occupation. This corner is accepted as a careful and faithful reestablishment of the position of the original corner.
