- A. Description of original monument and accessories and/or subsequent restoration:
- I-10 -GLO-Set 1/4 post-A. Curtis-1852 Y, Birch 12" N52°W 24L.

Hemlock 10" S48°E 4L.

- Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I-10 - 1/4 cor. common to sec. 26 & 27- Excavate 10'x15' area in swamp. Find 3"x3' long cedar post lying in swamp. At base of small end of post find six cobble stones -down 1.5'- Post base fits SP position between I11 & I9 which is consistent with Co. notes and fits Rd. Sur. dist S. within 2' and old fence N. PS# 30079 witnessed and accepted the recovery of this monument with me. Monument accepted as the best available evidence of the position of the original corner.

-Reference Pt. 'A' - Fnd. 1/2" rebar per record survey N15°50' W 6.18' of I-10. This rebar apparently replaced a PI spike for recent road construction S & E. Excavation around this iron revealed no evidence of a post. Monument established using improper procedures and is not utilized as I-10 in this survey.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

1-10 -Set 4" DNR A.C. on 1"x 6' galv. iron pipe at location of

post base end and cobble stones. Built ring of stone.

Set Carsonite post 1'SSE. Set Fnd. cedar post on N. side monument as a memorial below cap.
