- Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- L -9 -1/4 Cor, common to Sec. 24 & 25- No monument or evidence found. Re-established corner in CL, gravel Gaukel Rd, by Single Proportion to GLO E-W from J-9 to the east township line using a latitude that was determined by a line between J9 and a found 1 1/2" I.D. pipe to the East at Lake shore of the Reedsburg Dam flooding on the extension of CL. Gaukel Rd from the west. Cable wire N is 110' +/- E.

Monument accepted as a careful and faithful re-establishment of the position of the original corner.

- C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
- L-9 Set 4" AC with 4" X 1' PVC with concrete on 1" X 3' Iron pipe. Monument is set with ring of cobble stones around it. N55°W 47.15' to set nail and tag in NE side of 10" R. Pine scribed "XBT" N33°E 53.77' to set nail and tag in NW side 10" J. Pine scribed "XBT" Due South 50.67' to set nail and tag in W side of 4" Twin R. Maple scribed "XBT" S60°W 49.74' to set nail and tag in NW side of 5" R. Maple scribed "XBT"

Set 2" AC on 5/8" X 34" rebar with carsonite post 33.01' North on 1/4 line.
