

- B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:
- B7 ¼ Corner common to Sections 18 & 19, T24N, R7W Fd. ¾" I. D. pipe per J. L. Wilcox on North edge Gravel Rd. 7'± N of Centerline West. Fits one witness S71°E 83.94' (MDOT record) to 83.9'± 0.1' to reaction of nail in N. side of triple 19" Maple. Corner of fence line N & W is 31.5' ± W and 33' N. ¾" pipe is accepted as the best available evidence of the position of the original corner.

- C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
- B7 Drove 5/8" x 24" rebar inside fd. 3/4" I.D. pipe and set 2 1/2" stamped bronze cap encased with concrete inside a 6" wide x 10" tall galv. stove pipe form, down 0.8'.
