

- B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:
- E5 Section corner common to Sections 8, 9, 16 & 17, T24N, R7W Fd. 2 ½" O.D. x 0.9' long iron pipe in conc. cylinder with tin shell per J. G. Cavanagh survey 1909. Corner is 1.5'± South of centerline E-W 2-track. Found a witness from K. J. Ostling, J. L. Wilcox and two witnesses from C. F. Roser. Cavanagh monument is accepted as the best available evidence of the position of the original corner.

- C. Description of monument for corner and accessories established to perpetuate locating the position of the corner;
- E5 Replaced Cavanagh Mon. w/ stamped 4" DOC (DNR) Brass Cap on 1" x 36" galv. iron pipe with coffee can filled with concrete around cap. Placed broken pieces of old concrete monument around base as memorial. OF MICHIGAN S41°E 78.26' to set N & T in NE side 30" Oak (KJO, JLW, CFR)

N71°E 113.23' to set N & T in N. side 10' White Pine scribed 'XBT' N17°E 155.03' to set N & T in E. side 8" Red Pine scribed 'XBT'
