Beauregard in a field survey on May, 19 94, do hereby certify that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, re-monumented, recovered, found as expressed below:

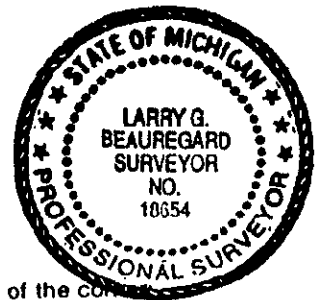
NOTE: Not more than 4 corners, all in the same town and range, may be recorded on this certificate.

A. Description of original monument and accessories and/or subsequent restoration:

- (J-13) GLO post set by Lewis Clason December 12, 1839.
 Wits: Beech 12" N 55° E 20 links Beech 9" N 19° W 52 links
 Delmer E. Porter P.S. #15410 in 1971 re-set 1/2" bar & P.S. cap by S.P. method. Wits marked: (N 50° E 34.23' 8" Oak), (Due North 14.40' 12" Oak) and (S 60° W 71.87' 12" Maple).
 Norman C. Caldwell P.S. #12018 in 1977 found 1/2" rod by Porter and replaced it with a standard County corner. Recorded L. 2, P. 438. Wits marked: (N 50° E 36.8' 8" Oak), (North 15.4' 12" Oak), (S 60° W 69.0' 12" Maple) (West 6.6' standard County corner). (Oscoda County Records, Recorded L. 2, P. 438).

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

- (J-13) Didn't find corners set by Caldwell in 1977. I did find two red top posts and one record witness by Caldwell. Also found two recorded witnesses by Porter, but they didn't agree with the Caldwell witnesses. So I re-ran the County line and set a 4" x 36" concrete monument with a 3" diam., Aluminum cap #18654 marked Montmorency County Remonumentation corner by S.P. method between (R) SE & SW corners on the County line.



C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

- (J-13) 1/4 corner common to Sec. 35, T 29 N, R 3 E
 4" x 36" Concrete mon. & Re-mon. cap, P.S. #18654. Accepted as a careful and faithful establishment of the position of the corner. Approved by the Peer Group on August 5, 1994.
