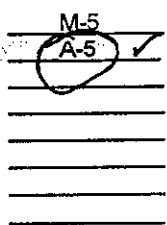

Found (2) ½" rods in mon. box, the Westerly rod was inside a 1" pipe and the centerline of the E & W road is 2 ft North and it is in the centerline of the N & S road and I measured 2665.68 ft from the S.E. Cor. to the E. ¼ Cor. of Sec. 12 and the condition of recorded witnesses are: #1 thru #5 gone, #6 thru #10 good condition.

**C. DESCRIPTION OF MONUMENT FOR CORNER AND ACCESSORIES ESTABLISHED TO PERPETUATE LOCATING THE POSITION OF THE CORNER:**

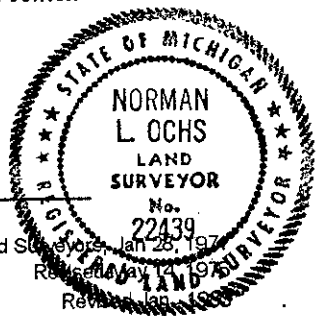
Removed (2) ½" rods and 1" pipe and set a 2¾" dia. Harrison cast iron monument in monument box 20" long marked "County Survey" as a substantial marker for the section corner and is accepted as a careful and faithful reestablishment of the original corner.
