Found a 3/4" Pipe with smashed cap and measured 2648.30 feet from the NE. Cor. to the E. 1/4 Cor. of Sec. 30 and condition of recorded witnesses are: \$1 and \$2 Gone, \$3 decayed stump only, \$4 and \$5 Gone, \$6 and \$7 Good Condition, #8 Gone, #9 Good Condition. In centerline of gravel road. There is an old fence on ground East and West. Also dug at bearing and distance from bearing tree No. 7, to try and determine if it was a O.B.T., did not find any evidence. It fell +- 3 feet West of road. I do not feel it is an O.B.T.
