## B. DESCRIPTION OF CORNER EVIDENCE FOUND AND/OR METHOD APPLIED IN RESTORING OR REESTABLISHING CORNER:

Found  $\frac{1}{2}$ " X 21" Rerod,  $\frac{2}{4}$ " X 24" Rerod and a  $\frac{2}{4}$ " X 28" Shaft with a 1" hexagon head (all right next to each other and held the  $\frac{1}{2}$ " Rod for position which was above the stone) and a large stone 0.5 feet  $\pm$  south (10" X 10" X 10"). The centerline of the East and West bituminous road is 1 foot North and the centerline of the two-track going South is 2 feet East. The condition of the recorded witnesses are: #1 thru #3 good condition.

## C. DESCRIPTION OF MONUMENT FOR CORNER AND ACCESSORIES ESTABLISHED TO PERPETUATE LOCATING THE POSITION OF THE CORNER:

Removed Rerod, Shaft and Stone and set a 2¾" X 20" Harrison cast iron monument marked "County Survey" in a new 8" diameter monument box as a substantial marker for the section corner.

48" Maple (blazed) S28°E 34.20' Set spike with tag #22439 in West side of tree. #1 26" White Oak N60°W 64.64' Set spike with tag #22439 in South side of tree. #2 Southeast Corner Concrete Foundation House #5993 N15°E 65.04' #3 Power Pole N68°E 70.26' Found spike with tag (illegible) in Northwesterly side of pole.
