B. DESCRIPTION OF CORNER EVIDENCE FOUND AND/OR METHOD APPLIED IN RESTORING OR REESTABLISHING CORNER:

Found 5/8" X 18" Copper Rod next to remains of a wood stake 18" below grade in broken monument box. Large metal object 44" below grade. On line ± with the centerline of the North and South and East and West bituminous roads. The condition of the recorded witnesses are: #1 thru #9 gone, #10 thru #13 good condition.

C. DESCRIPTION OF MONUMENT FOR CORNER AND ACCESSORIES ESTABLISHED TO PERPETUATE LOCATING THE POSITION OF THE CORNER:

Removed remains of Wood stake, 5/8" X 18" Copper Rod and set a 2¾" X 20" Harrison cast iron monument marked "County Survey" over large metal object and grouted in place in broken monument box with no lid as a substantial marker for the section corner and is accepted as a careful and faithful reestablishment of the original corner.
