## B. DESCRIPTION OF CORNER EVIDENCE FOUND AND/OR METHOD APPLIED IN RESTORING OR REESTABLISHING CORNER:

Found previous witness by Lyle S. Shepherd (Pine Stump) ± 2 feet below road surface and the centerline of North and South two-track is four feet East and thirty-four feet West of North and South right-of-way fence and there is a fence line going East 72.58 feet North. I feel that George Blass, Duane Wood and Thomas H. Sage used the incorrect position for this corner. I measured 72.58 feet from Lyle S. Shepherd's Corner North to 1" Iron used by Blass, Wood and Sage and I measured 5443.85 feet from the Northeast Corner to the Southeast Corner of Section 1 and measured 2749.19 feet from the Northeast Corner to the East One Quarter Corner of Section 1 and measured 2699.66 feet from the East One Quarter Corner to the Southeast Corner of Section 1 and the condition of the recorded witnesses are: #1 and #2 gone, #3 remains of Pine Stump, #4 thru #10 witnesses for incorrect corner.

## C. DESCRIPTION OF MONUMENT FOR CORNER AND ACCESSORIES ESTABLISHED TO PERPETUATE LOCATING THE POSITION OF THE CORNER:

Set 4" diameter Harrison cast iron monument 15" long marked "County Surveyor" as a substantial marker for the section corner and is accepted as a careful and faithful reestablishment of the original corner.
