Found 1" pipe on top of a 1"x¼" flat iron and I measured 2654.64 ft from the N.W. Cor. to the N. ¼ Cor. of Sec. 34 and measured 2656.23 ft from the N. 1/2 Cor. to the N.E. Cor. of Sec. 34. The centerline of the E&W road is 6 ft North and is on old fence line to the North and the condition of the recorded witnesses are: #1 thru #5 gone, #6 and #7 good condition, #8 gone, #9 been hit, #10 and #11 good condition

### C. DESCRIPTION OF MONUMENT FOR CORNER AND ACCESSORIES ESTABLISHED TO PERPETUATE LOCATING THE POSITION OF THE CORNER:
