B. DESCRIPTION OF CORNER EVIDENCE FOUND AND/OR METHOD APPLIED IN RESTORING OR REESTABLISHING CORNER:

Found a 5/8" X 9" Rerod over a 1" X 3" Pipe in curve of road. The extension of road going North would place the Rod in the centerline. The centerline of the North and South bituminous road is 8 feet West and the centerline of the gravel road going East is 6 feet North. In 1968 William B. Batzer measured 1244.21 feet from the Northwest Corner of Section 30 to the Northeast Corner of "Old Orchard Number 2" and I measured 1244.37 feet. The condition of the recorded witnesses are: #1 thru #7 gone, #8 good condition, #9 gone (may have been hit when ditch / culvert was updated), #10 thru #12 good condition.

C. DESCRIPTION OF MONUMENT FOR CORNER AND ACCESSORIES ESTABLISHED TO PERPETUATE LOCATING THE POSITION OF THE CORNER:

Removed Rerod and Pipe and set a 4" diameter Harrison cast iron monument 20" long marked "County Survey" as a substantial marker for the section corner and is accepted as a careful and faithful reestablishment of the original corner. ne. OF MICHIGAN
