B. DESCRIPTION OF CORNER EVIDENCE FOUND AND/OR METHOD APPLIED IN RESTORING OR REESTABLISHING CORNER:

Found 6" Spike in 1" X 10" Iron Pipe over a 10" Dock Spike. Detected metal still in hole. The centerline of the East and West road is 2.5 feet North and in the centerline of the North and South gravel road. The condition of the recorded witnesses are: #1 and #2 gone, #3 Found, but the original wood fence Wood Post was replaced with 5" steel fence post filled with concrete as told to me by Floyd Dickson, owner of the fence, #4 found, but stone has been moved, #5 good condition, #6 gone, #7 good condition, #8 found pipe laying nearby.

C. DESCRIPTION OF MONUMENT FOR CORNER AND ACCESSORIES ESTABLISHED TO PERPETUATE LOCATING THE POSITION OF THE CORNER:

Removed Spikes and Iron Pipe and set a 4" diameter Harrison cast iron monument 20" long marked "County Surveyor" over metal in hole, as a substantial marker for the section corner and is accepted as a careful and faithful reestablishment of the original corner.

5" Steel Fence Post filled with concrete S40°W 46.60' Replaced R.A.G. tag. #3
"X" Cut in top center Stone 2.0' X 2.5' X 4' N60°W 76.82' (±33' North of section line)#4
14" Red Pine N30°W 111.28' Set spike and tag in Southwest side of tree. #5
Corrugated Metal Pipe N47°W 32.72' bent at North end. #7
Power Pole S67°E 168.40' Found spike in North side of pole. #9
16" Cherry N54°E 95.90' Set spike and brass washer #22439 (blazed) on Northwest side
