Found 1/2" rod and the centerline of the N & S gravel road is 9 ft West and measured 2632.84 ft from the N.W. Cor. to the W. 1/4 Cor. of Sec. 18 and measured 2606.35 ft from the W. 1/4 Cor. to the S.W. Cor. of Sec. 18. and the condition of the recorded witnesses are: #1 thru #6 gone, #7 thru #10 good condition.

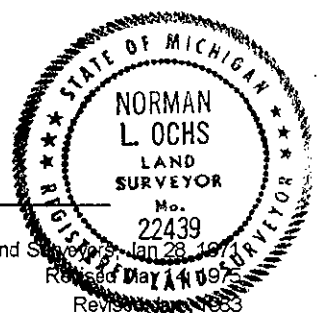
