

DOSSIER FOR: THE SOUTH 1/4 CORNER OF SECTION 30, MILFORD TOWNSHIP, T 2 N, R 7 E, OAKLAND COUNTY, MICHIGAN. Prepared under contract with the County of Oakland Under Act 345 of the Public Acts of 1990.

HISTORY:

This Corner has been accepted and used since before 1945, as evidenced by an unrecorded survey by the Huron-Clinton Metropolitan Authority. This Corner has not been previously recorded.

COLLATERAL EVIDENCE:

We set a concrete monument and remonumentation cap based on the coordinates from the 1945 survey. There is a rock row running to the East and a very old fence running North. We measured 0.26 feet more than the recorded distance to the Northwest Corner of Section 31 and the same distance as the record to the Northeast Corner of Section 31. We searched at least 50 feet in each direction for other stakes and found none that might represent the Corner.

SURVEYOR'S RECOMMENDATIONS:

This corner location is accepted by the Contractor and is generally accepted by Professional Surveyors as the best available evidence of the position of the original Corner. Therefore, I recommend that the Peer Review Group accept this Corner as monumented, with the references as shown on the enclosed form prepared according to Act 74 of the Public Acts of 1970.
