DOSSIER FOR: THE WEST 1/4 CORNER OF SECTION 22, MILFORD TOWNSHIP, T 2 N, R 7 E, OAKLAND COUNTY, MICHIGAN. Prepared under contract with the County of Oakland Under Act 345 of the Public Acts of 1990.

#### **HISTORY:**

This Township was originally surveyed by Joseph Wampler, Deputy Surveyor, in 1823.

### **SPECIAL NOTES:**

After reviewing the transcripts of the Original GLO Notes, I believe that the original survey lines were run as documented and that the dimensions seem to be accurate in the Southeast 1/4 of this Township, with our measurements agreeing within 10 to 15 feet, in practically all instances.

This Corner has been accepted and used since before 1984, as evidenced by a survey

recorded by Raymond J. Kostecke in Liber 9387, Page 858.

## **COLLATERAL EVIDENCE:**

This Corner lies in a Monument Box in the Centerline of Milford Road and on line with a fence that runs to the West.

We searched at least 50 feet in each direction for other stakes and found none that

might represent the Corner.

The measured dimension to the Southwest Corner of Section 22 agrees with the dimensions taken from recorded surveys, the most recent tax maps and/or other old surveys within one half of a foot.

This Corner was first recorded in 1984 by Raymond J. Kostecke in Liber 9387, Page 858, of the Oakland County Records.

## **SURVEYOR'S RECOMMENDATIONS:**

Therefore, I recommend that the Peer Review Group accept this Corner as monumented, with the references as shown on the enclosed form prepared according to Act 74 of the Public Acts of 1970.
