

DOSSIER FOR: THE SOUTHWEST CORNER OF SECTION 13, MILFORD TOWNSHIP, T 2 N, R 7 E, OAKLAND COUNTY, MICHIGAN. Prepared under contract with the County of Oakland Under Act 345 of the Public Acts of 1990.

HISTORY:

This Corner has been accepted and used since before 1935 as witnessed by the Road Commission for Oakland County at that time. It was not previously recorded under Act 74 of the Public Acts of 1970.

COLLATERAL EVIDENCE:

We set a concrete monument with remonumentation cap in place of a 1" iron pipe. There is a fence line running North and West from the Corner. Childs Lake Road runns South 21 feet East of the Corner. We measured 0.14 feet more than the recorded distance to the South 1/4 Corner of Section 14 and about 3 feet more than the GLO to the South 1/4 Corner of Section 13.

We searched at least 50 feet in each direction for other stakes and found none that might represent the Corner.

SURVEYOR'S RECOMMENDATIONS:

This corner location is accepted by the Contractor and is generally accepted by Professional Surveyors as the best available evidence of the position of the original Corner. Therefore, I recommend that the Peer Review Group accept this Corner as monumented, with the references as shown on the enclosed form prepared according to Act 74 of the Public Acts of 1970.
