DOSSIER FOR: THE EAST 1/4 CORNER OF SECTION 36, MILFORD TOWNSHIP, T 2 N, R 7 E, OAKLAND COUNTY, MICHIGAN. Prepared under contract with the County of Oakland Under Act 345 of the Public Acts of 1990.

HISTORY:

The East Boundary of this Township was originally surveyed by Alex Holmes, Deputy Surveyor, in 1816.

SPECIAL NOTES:

After reviewing the transcripts of the Original GLO Notes, I believe that the original survey lines were run as documented and that the dimensions seem to be accurate in the Southeast 1/4 of this Township, with our measurements agreeing within 10 to 15 feet, in practically all instances.

This Corner has been accepted and used since before 1983, as evidenced by an unrecorded survey by Raymond J. Kostecke.

COLLATERAL EVIDENCE:

We set this Corner Northerly 40.54 feet from the West 1/4 Corner of Section 31 (per Mr. Kostecke's survey) of Commerce Township (found iron pipe) and on line with it and the Southeast Corner of Section 36 of Milford Township. We also found an iron pipe 73.49 feet South of the Corner.

We searched at least 50 feet in each direction for other stakes and found none that

might represent the Corner.

The measured dimension to the Southeast Corner of Section 36 agrees with the dimensions taken from recorded surveys, the most recent tax maps and/or other old surveys within 1.5 feet.

This Corner has not been recorded previously.

SURVEYOR'S RECOMMENDATIONS:

Therefore, I recommend that the Peer Review Group accept this Corner as monumented, with the references as shown on the enclosed form prepared according to Act 74 of the Public Acts of 1970.
