

We searched at least 50 feet in each direction for other stakes and found none that

might represent the Corner.

The measured dimensions to the Southeast Corner of Section 6 agrees with the GLO dimension within 7.5 feet and surveys within 0.2 feet (Albright). The measured dimensions to the Southwest Corner of Section 6 agrees with surveys within 0.2 feet (Newman & Sheridan).

SURVEYOR'S RECOMMENDATIONS:
