## B. Description of corner evidence found and/or method applied in restoring or reestablishing corner

I found a 3/4" id Pipe, 3' below the surface of a newly constructed north-south Gravel Road. Old Fence and tree line runs to the west. One OCRC Maple tree witness is still standing. LCRC 100454 records that this pipe is 33' west of the plat concrete monument. LCRC 100454 witnesses measure good.

Further search of the area failed to yield any other evidence for a conflicting position for the corner. This represents the best available The Found 3/4" Pipe is accepted as a careful and faithful perpetuation of the position of the evidence for the position of the corner.
