B. Description of corner evidence found and/or method applied in restoring or reestablishing corner

I found an Engine Valve in the surface of the center of an east-west, and north asphalt road intersection. All Ross witnesses are standing and measure good. One OCRC witness is standing - 18" Maple S70E 66.3, which is now a 48" Maple.

Upon removal of the engine valve, I excavated to 14" below the surface of asphalt and found a wood post with a very brittle, very old and well- rotted axle shaft along side. The axle disintegrated upon attempting to drive it down. The post and axle were found at the top of the sand grade, just below the gravel grade. The engine valve was found to be directly over the wood post. I believe that this axle is the OCRC corner "set in original" wood stake"; and that the wood post was set by Hawley in 1876 from the remaining Gov't witness.

Further search of the area failed to yield any other evidence for a conflicting position for the corner. This represents the best available evidence for The Found EngineValve riser is ACCEPTED AS A CAREFUL AND FAITHFUL PERPETUATION OF THE POSITION the position of the corner. OF THE ORGINAL CORNER.
