Description of corner evidence found and/or method applied in restoring of reestablishing corner:

I found a 1/2" iron in center of 3" clay tile 6 feet more or less west of centerline of North and South road and in line more or less with old fence (down) running West. I also found a 1" pipe with an Osceola County Remon Cap, which was directly over a 4" diameter Concrete Monument. This 1" pipe was S54°E 12.65 feet from the clay tile. I accepted the clay tile as the correct corner. I removed the 1" pipe with Osceola County Remon Cap but left the 4" Concrete Monument.

Description of monument for corner and accessories established to perpetuate locating the position of the corner: I placed as 1" x 18" Iron Pipe with an Osceola County Remon Cap in the center of the 3" Clay Tile and is accepted as a careful and faithful perpetuation of the position of the original corner.
