

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

 $\underline{\text{K-4}}$ - 1/4 cor. common to Sec.11 & 12- Set 4" DNR Alum. Cap on 1" x 28" galv. iron pipe in ring of stone from the remains of two Co. Survey BT stumps. Position falls in fence remains N & S. Fits GLO examination distances to K-5 and K-3 within reason. Fits Co. dist. to K-3 within 11'. Co. Dist to K-5 appears to be short by a chain. This position is believed to have been perpetuated by Co. Surveyor F. Trumbull in the early 1900's and is accepted as the best available evidence of the position of the original corner.

Reference Pt. 'C'- Found capped 1/2"rebar # 25862 per record LCRC is N0°39'W 19.94' from Set DNR Monument. Could find no evidence of E-W fence in this area. The closest fence to the west was found at J4 where the Fences go S & W but this position doesn't project east to this capped iron. Fnd.1/2"rebar was apparently established without regard to the record Co. Surveyor notes. Capped 1/2" Rebar is not utilized as K-4 in this survey.

K-4 -DNR Monument per part 'B' with carsonite guard post 1'W NO °39'W 19.94' to capped rebar being Reference Pt. 'C' N48°E 8.05' to set spike in CL 20" ± W. Pine Stp. remains (Old NBT) S29°W 9.9' to set N&T in face 12" R.(Norway) Pine Stp. (Old NBT) N87°E 20.29' to set N&T in N side 3" R. Maple scribed 'XBT' S22°E 50.10' to set N&T in NE side 19" 1%. Oak scribed 'XBT' S44°W 61.42' to set N&T in SE side 10" R. Pine scribed 'XBT' N82°W 51.78' to set N&T in S side 9" R. Pine scribed 'XBT'
