


- 5. Private Claims

- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

K-5 - Sec. cor. common to Sec.11, 12,13 & 14- Fnd. narrow gauge RR Track Iron 4' long per Co. Notes,LCRC and Rec. Surveys with remains of two Co. BT stp's in agreement with its position. Measure 34' E (66'-GLO) to edge of beaver pond (willow swamp-GLO)willow swamp. Measure N 359' (368'-GLO Exam.) to S Edge pond. 5' S & 16' W is fallen anchor post of ancient fences N, S & W. This RR Monument is believed to have been perpetuated by Co. Surveyor F. Trumbull in the early 1900's and is accepted as the best available evidence of the position of the original corner.



C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

K-5 - Replace RR iron with 4" DNR Alum. Cap on 1" X 4' Iron Pipe in ring of stone with carsonite post 1.7' NE
Reset RR iron on N. side below gnd. as a memorial.
N9°E 17.93' to set spike in CL,36" W. Pine Stp. remains (Old NBT)
S59°E 13.26' to set nail in CL. 30" W. Pine Stp. (Old NBT)
N57°W 61.01' to set N&T in NW side 4" R. Pine scribed 'XBT'
N30°E 53.28' to set N&T in SE side,
31" W. Pine scribed 'XBT'(HJM)
S9 °E 57.25' to fnd. nail in W side Tw. 21" R. Oak (HJM)
S70°W 30.28' to set N&T in N side 16" Poplar scribed 'XBT'(HJM)
