B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

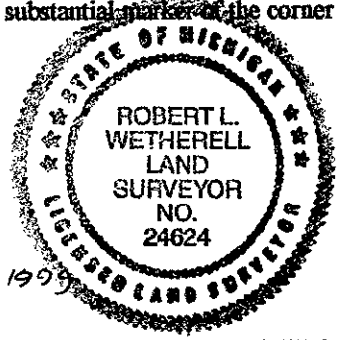
I found an Osceola County Monument by McClung in the intersection of fences North, South, East and West. I did not recover the plow point that Blass had in 1968.

Condition of the accessories are as follow: #1 Gone, #2 Gone, #3 Found in good condition, #4 Gone, #5 Gone #6 Found in good condition, #8 Found in good condition and #9 Found in good condition.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

I accept the Osceola County Monument (1 ½" pipe with an Osceola County Remon Cap) as a substantial marker of the corner and is accepted as a careful and faithful reestablishment of the position of the original corner.
