A. Description of original monument and accessories and/or subsequent restoration:

The corner was set by deputy surveyor John Hodgson on December 8, 1837. Set wood post 40.00 chains from the South.

Beech 8" S25W 37 Lks.

Beech 12" N47W 65 Lks.

From 1891 to 1904 approximately, Osceola County had a remonumentation program, in which surveyors Temple and Trumbull, did the work. For the most part, a 3" glazed tile filled with cinders from a forge, were placed at each government set corner in the township. There were supposed to be 3 tile per corner, placed atop of each other, (continued on back)

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found well screen for post. Set Osceola County monument 30" long to position and removed well screen and left screen on surface.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Corner A-2. is Osceola County Monument, which is a 3" brass cap mounted on a 1" pipe 30" in length.
