A. Description of original monument and accessories and/or subsequent restoration:

The corner was set by deputy surveyor John Hodgson on December 8, 1837. Set wood post 40.00 chains from the South.

Beech 7" S73W 15 Lks. Lynn 16" N58W 34 lks.

From 1891 to 1904 approximately, Osceola County had a remonumentation program, in which surveyors Temple and Trumbull, did the work. For the most part, a 3" glazed tile filled with cinders from a forge, were placed at each government set corner in the township. There were supposed to be 3 tile per corner, placed atop of each other, (continued on back)

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found 1/2" re-bar 2" below road surface, 2' long. removed re-bar and excavated to 26" and found 2"X 2" wood stake surounded by large stones. Notes call for tile and wood stake. Set Osceola County Monument over wood stake, which is 3" S40W of position of rebar. Monument is 6" below road surface. ST MATTHEW

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner AND Corner M-11. is Osceola County Monument Corner M-11. is Osceola County Monument, which is a 3" brass cap mounted on a 1" pipe 18" in length.
