A. Description of original monument and accessories and/or subsequent restoration:
The original corner was set by deputy surveyor Sylvester Sibley on 22 May 1838. Set wood post 40.00 chains from South.
Beech 8" N54E 30 Lks.
Ironwood 6" N23W 12 Lks.

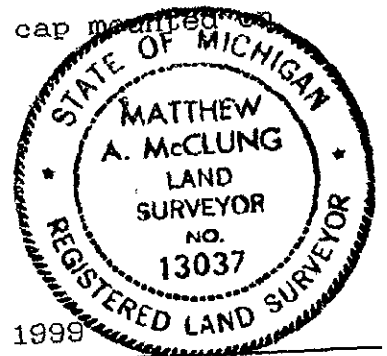
From 1891 to 1904 approximately, Osceola County has a remonumentation program, in which surveyors Temple and Trumbull, did the work. For the most part, a 3" glazed tile filled with cinders from a forge, were placed at each government set corner in the township. There were supposed to be 3 tile per corner, placed atop of each other, (continued on back)

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Hired back hoe to dig corner. Excavated to 8 feet and found Iron in tile. Placed Osceola County Monument in position of Tile 6" below surface. Corner is 3 feet West of C/L of North and South Road, in 2 track Rd East and 4 feet South of Fence Row West. Erickson corner is S27-44W 16.01 feet.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Corner M-10 . Osceola County Monument, which is a 3" brass cap mounted on a 1" pipe 18" in length.
Fence Post N84W . 29.50 feet.
8" Db1. Elm S24W 51.35 feet.
Telephone Pedestal N46W 36.87 feet.
10" Maple N58E 75.50 feet.

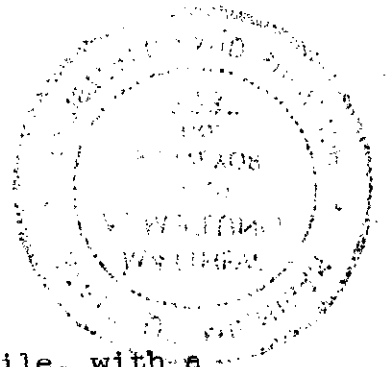
