A. Description of original monument and accessories and/or subsequent restoration:

The original corner was set by deputy surveyor Sylvester Sibley on 22 May 1838. Set wood post 80.00 chains from South.
Beech 12" N65W 25 Lks.
Sugar 8" S36W 20 Lks

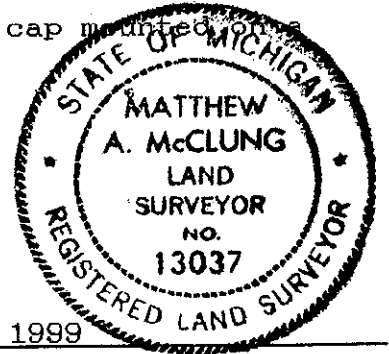
From 1891 to 1904, approximately, Osceola County has a remonumentation program, in which surveyors Temple and Trumbull, did the work. For the most part, a 3" glazed tile filled with cinders from a forge, were placed at each government set corner in the township. There were supposed to be 3 tile per corner, placed atop of each other, (continued on back)

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found nail and I.D. Cap #28432 in C/L of East and West Road and 3 feet West of C/L of North and South Road. Removed nail and put in P.K. nail with the found I.D. cap. I used a PK nail because the North and South road is a cement road with a layer of asphalt on top.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Corner M-11. Osceola County Monument, which is a 3" brass cap mounted on a 1" pipe 18" in length.
Tele. Ped. N55W 58.75 feet. O.B.T.
Tele. Ped S60E 63.35 feet. O.B.T.
Power Pole w/nail N22E 116.5 feet. O.B.P.
4" Elm S65W 51.75 feet.



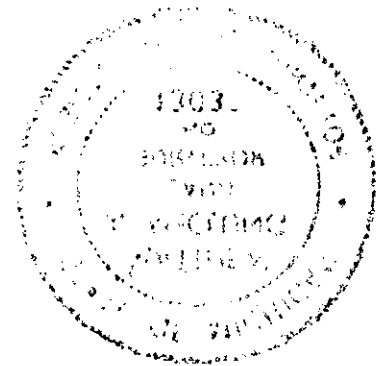
