A. Description of original monument and accessories and/or subsequent restoration:

GLO 1/496: A.P. Brewer, 1856: Old Post-Sugar 12" N 62°E 30 lks (19.8'), Y.Birch 10" S 38°E 27 lks (17.8'). CSR 2/416: G.F. DeLaMater, 1935: Found Post & roots of Gov. Birch, set 1½" Pipe in corner-Crankshaft N 45°E 46.6', Maple 4" S 60°E 53.0', W.Pine stump 36"S 2°W 20.6', W.Pine stump 48" S 22°W 95.3'.

Survey: K.R. Larsen, 12/1966 & 1/1967: Found 1½" Pipe-Crankshaft N 45°E 46.6', W.Pine stump S 2°W 20.6', Fence N.& S East 5.0'.

Survey: L.L. Cavanagh, 10/72: Found $1\frac{1}{2}$ " Pipe-Crankshaft N 45°E 46.6', W.Fine stump S 2°W 20.6', 4" Maple S 60°E 53.0', Fence N & S East 5.0'.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found $1\frac{1}{2}$ " Iron Pipe 10" deep & $2\frac{1}{2}$ ' south of centerline of 14' gravel road, Crankshaft northeast and remains of W. Pine stump south. Also fence N & S East 5.0'.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Set Otsego County Monument top over $1\frac{1}{2}$ " Iron pipe approximately $2\frac{1}{2}$ ' south of centerline 14' gravel road, a accepted as a careful and faithful perpetuation of the position of the original corner-spk 12" Beech N 19°E

39.58', Crankshaft N 45°E 46.6', spk 10" Maple 40.80', spk 12" Maple S 30°W 66.40', Fence line N & S East 6'±, 1"x4"x48" Treated Wood Stake North 16.0'.
