B. Description of comer evidence found and/or method applied in restoring or reestablishing corner:

I found no remains of the original corner or accessories. I also found no remains of M.S.H. D. corner or ties. An East-West gravel road now runs over the area of the Corner. I found a 5/8" Iron pin on the South edge of the gravel road. This iron pin set by an unknown surveyor appears to have been re-established by single proportionate measurement. It works well with other corners in the area. I accepted the 6/8" iron as the 1/4 Corner and placed an aluminum cap on it.

Research on file with County Remonumentation Representative.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Corner is a 5/8" iron pin with a 3" diameter aluminum cap stamped to read: COUNTY REMONUMENTATION; 1998; 1/4; S.11, S.14; T.47N, R.38W; P.S. 37273. I also established a Reference Monument (R.M.) to the North, stamped to indicate that the Corner is South a distance of 28.93 feet. Corner falls 8 feet South of centerline of gravel road.
