

At the corner position I found a $1\frac{1}{4}$ " I.P. in a monument box 2 feet East of the centerline of Highway US-45 and 28 feet South of a blacktop county road running East. This was shown on the Michigan D.O.T. drawings dated April 20, 1960. Distance on West line of Section 10 and a stream call are in conformance with original notes. I accepted the location as being the only logical position for the corner.
