B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Corner position is in a road (Old M-28) which has been in existence since about 1915. No original evidence was found. At the apparent corner position a new fence line runs North. A fence in poor condition running South does not line up with the one running Testimony from an elderly resident in the area told me the fence running South was placed there by agreement with his grandfather and a neighbor because of a nonfarmable swampy area. Fence was placed East of the true location. I monumented the corner in line with the fence running North.

I established a reference monument, a $2\frac{1}{2}$ "X30" split base aluminum pipe with a 3" cap stamped to read the same as above. I also established three other reference objects.
