B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

No evidence of original corner was found. A cedar post was found near the corner position. An old fence (60 yrs.  $\pm$ ) runs West from the North  $\frac{1}{4}$  corner of Section 6 but ends about 400 feet East of the NW corner of Section 6. A projection of this fence places the corner 83 feet North of the Cedar Post. This location is in better agreement with the original field note calls. I monumented the corner as described in "C" below. This corner is one of 29 corners in 6 Sections remonumented under the County Remonumentation Program. Research is on file with the Ontonagon County Remonumentation Representative.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
