

He set a  $2\frac{1}{2}$ " by 5' galvanized iron pipe with a 3" stamped brass cap and the following new bearing trees: --- 8" (13") Sugar Maple N.41 W. (N.40 W.) 45.7' (45.54') --- 10" (15") Sugar Maple S.89 E. (S.89 E) 49.3' (49.30') --- 9" (14") Sugar Maple S.13 E. (S.10 E) 48.0' (38.15').
