

Corner restored by Donald D. Lappala, RLS 12585 on 6/17/69 from the downed and scribed Sugar Maple B.T. and the stump hole of the Aspen B.T. He set a $2\frac{1}{2}$ " by 5' galvanized iron pipe with a 3" stamped brass cap and the following new bearing trees: --- 6" (7") Sugar Maple N.34 W. (N.34 W.) 23.1' (23.11') --- 5" (6") Sugar Maple S.35 E. (S.37 E.) 19.7' (19.70') --- 4" (6") Sugar Maple S.47 W. (S.53 W.) 6.6' (6.70') ---.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
