He set a 2" dia. aluminum pipe with a 31/4" stamped aluminum cap and the following new bearing objects: --- 9" (12") Red Maple N.10 W. (N.12 W.) 27.13' (27.12') --- 18" (20") Hemlock N.87 E. (N.86 E.) 34.32' (34.25') --- 15" (16") Hemlock S.02 E. (S.03 E.) 18.75' (18.76') --- 6' Metal sign post N.69 E. (N.68 E.) 2.25.
