

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

No original evidence was found. Area was completely cleared in 1970 for the base of a huge crushed slag pile. Part of the slag pile has been removed allowing the corner to be set in its proper position. The corner was re-established by single proportionate measure and on line between opposite section corners North & South.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

At the corner position I set a  $2\frac{1}{2}$ "X30" split base aluminum pipe with a 3" cap stamped to read: County Remonumentation, T51N, R41W, R42W, 4, \$31, \$36, 1998, P.S. 17610. I established 3 bearing trees and two reference objects.
