B. Description of comer evidence found and/or method applied in restoring or reestablishing corner:

Found Remon Capped Iron in Mon Box

The St. Joseph County Land Corners being located were done within specifications for Order "C 2-II". The closest the National Geodetic Reference System monument having a position order of "B" incorporated in the traverse network was the monument having the PID of "AA8117" with Station Name of "IRS-F". The maximum positional error of each Land Corner monument being located would be less than 0.08 feet relative to the connecting HARN control monuments of the National Geodetic Reference System based on a 95% confidence level.
