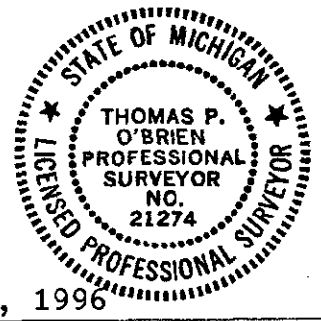
M-4 Nov. 5, 1969- Frank J. Bray, RLS set a 1" pipe with 4" Aluminum cap.
