- E-11 Southeast cor. of sec. 29. O.B.T.'S. Wood Post, Cedar 14", N64°W, 14 lks. and Cedar 12", S45°E, 07 lks.
 - B. Description of corner evidence found and/or method applied in restoring or re-establishing corner:
- Ell Set on a line extended from the S.E. sec. cor. of sec. 28 across a 20" Cedar stump for the line tree on line bet. secs. 28 & 33 recorded as "West 61.08 Cedar 18" in Diam." This stump is cut low and therefore shows no hack marks but it is the only one in the area large enough to have been an 18" Cedar at the time of the original Gov't Survey. The E-W position was determined by a single proportion using the sec. cor. 1 mile East and the 1/4 cor. 12 miles West. This position fits the stream call 26.38 chs. North and is reasonable for swamp calls in the area (swamp edges in most cases are not definite.).
